

# VILLAGE OF LEXINGTON – DECLARATION OF ESTIMATED TAX

## INSTRUCTIONS

Individual taxpayers, who expect to receive taxable income, are required to make estimated tax payments when their tax liability is at least \$200.00. Taxpayers must have 90% of their current year's tax liability estimated tax paid by January 15, 2022, in order to avoid penalty and interest charges.

### **Due Dates:**

First voucher: 04-15-2021 (the first estimated payment is also listed on the 2020 tax return.)

Second voucher: 06-15-2021

Third voucher: 09-15-2021

Fourth voucher: 01-15-2022
